CHAPTER I

INTRODUCTION

In this research the researcher discusses seven points related to the topic. They are background of the study, research problem, objective of the research, research hypothesis, significance of the research, scope and limitation and definition of key term.

A. Background of the Research

Language is a system of communication for both spoken or written form which is used by some countries in the world. Richard and Vacca (1998: 11) stated that language makes a sense of the world, understand, and be understood. It can be restated that every language has meaning. From those meaning which are structured in a good pattern, it will make a human understand what is being spoken. Beside, Brown (2000: 5) stated that language is a system of arbitrary conventionalized vocal, written, or gestural symbol that enable members of a given community to communicate intelligibility with one to another. It means that language is a tool for human to have a communication. When the structure are not structured well, it can raise a misunderstanding between the communicators. If the pattern of language are structured well, the information can be delivered well.

Many students cannot use English well, because they confuse to use the patterns of good sentences. By studying grammar in good way, especially tenses the researcher believes that it would help them to be able in using English orally

or even in writing. In addition, many students cannot use the formula of tenses, because it different from grammar in Indonesian language. Therefore, that student's ability in grammar still low.

Grammar is the way in which words are put together to make a good sentence. The words must be structured with certain formula to make it sense. When the words put arbitrary, sometimes it does not have a meaning. If those unstructured words are used in a communication, the information cannot be delivered well.

Teaching grammar mean, give information or knowledge from the people who are more competent to the other who need help to make them more understand in grammar. It means that, when someone feel confuse to understand grammar, they need someone or things to make them easily understand, it is called teaching grammar. Canale and Swain (1980) states that grammar is viewed as one component of communicative competence. Without grammar, learner can communicate effectively only in a limited number of situations. In addition, Garner (1989) believes that grammar gives the learner a means to analyze and describe language. Thus teaching grammar is very important for students when they need help to understand the grammar it self.

The way to teach grammar is also very important for both of learner and teacher. When they have a good communication during delivering the knowledge, the learning process of understanding grammar is running well. A good communication means, when the teacher said something, the students will catch the same meaning with the teacher's desire. In opposite, when one of the subjects

can't follow the rules of teaching learning process, the goal of study can't be reached well. Thus, teachers should be able to make the atmosphere of classroom be more enjoy full. If the teacher can build this condition, the students will be easily understand the material faster.

Today there are two forms of teaching. The first one is conventional way. It means that the students are taught by using board as the media and the test form is paper based test. It has already used many years ago. The second is mobile learning or "M-Learning". It offers modern way in delivering the knowledge through mobile devices, such as handheld and tablet computers, mp3 players, smartphone, and mobile phones. Those mobile devices can be used as the media for teaching and learning.

The condition of students Grammar achievements on tenses in Islamic Senior High School Kota Blitar are still low. It can be seen from the student's task when the researcher did internship there. The researcher found many errors in tenses. Because of these errors, the students score is not maximum. Thus, the researcher conducted this research by using English Grammar Application to make the students easily understand in grammar. This is an application in smartphone that can be used for learning process.

In addition, based on the researcher observation in that teaching practice, there are three difficulties in of students in mastering Simple Past Tense. The first is students do not know the correct formula of simple present tense. Second, the students often make some mistake in using the verb in form of regular and

irregular. The third, the way of teaching learning make the students were not enthusiastic.

In order to solve the problem, the researcher need to use other technique to make the students be more enthusiastic in learning grammar especially Simple Past Tense. One of the technique is change the media for learning process using modern media. The researcher has searched some application in playstore to help the students in learning grammar. The researcher found an application named English Grammar Application.

English grammar application is an application with material about tenses inside. The students can learn individually with this application and then they can measure their achievement by seeing their score directly. In this application, the students will find question about grammar and they can do the test or even practicing using this application every time and everywhere. If they are diligent to practice and learn the material inside the application, the researcher believe that they will be able in using tenses.

C. Objective of the Research
