

CHAPTER V

CONCLUSION AND SEGGESTION

The last chapter embodies two section: conclusion and suggestion. The conclusion contains the summarizing of the main result of the research. While in suggestion, it consist of the researcher's recommendation related to the result of this study.

A. Conclusion

Related to the data finding, it reveals that there are about 1888 utterances which occur in the dialogue of *Divergent* movie. However the researcher have reduced some utterances and focused only into utterances performed by Dauntless Faction to observe the Hedges. It is found 29 utterances to observe the hedging maxim and 17 utterances to observe the factors that influence(s) the occurrence of Hedges by Dauntless Faction in *Divergent* movie. These data are classified according to the hedging maxim of Cooperative Principle proposed by Grice and Yule.

The first research problem was to find the types of hedges used by dauntless faction. The researcher found all of the hedging maxim. It is found 29 utterances, where 13 data belong to hedging maxim of quality, 7 data hedging maxim of quantity, 6 data hedging maxim of relation and 3 data belong to hedging maxim of manner. Based on the data, the hedging maxim of quality became the most frequently than others, the second is hedging maxim of quantity, the third is hedging maxim of relation with the 6 total data was found, and the last is hedging maxim of

manner with the data was found most a bit between hedging maxim of quality, maxim hedging of quantity, and maxim hedging of relation.

The second research problem was about the factors that influencing of hedges by dauntless faction in divergent movie. The first factor that is because the uncertainly of the utterances, the second; because limited information of the speaker, the third; because the speaker or the utterances wants to move to another topic, and the last; to make sure that the hearer will understand.

B. Suggestion

The researcher expected this research could enrich the readers' understanding about the concept of hedging maxim of Cooperative Principle, and the factors that influencing the occurrence of hedges by analyzing through the situational context. In order to develop the study in Pragmatics, the researcher suggested:

1. The researcher expect that the study gives contribution for a better concept and understanding about hedging.
2. In understanding the hedging maxim of Cooperative Principle, teacher can use movie excerpts in order to give a clear explanation of the application of the theory. In other words, the excerpts of this movie can be used as a teaching media in explanation the use of hedging g maxim of Cooperative Principle in the real situation. Moreover, it will help students to analyze the theories of Pragmatics not only theoretically but also contextually.

3. This study can also be used as a reference for those who are interested in studying hedging because hedging is a kind of pragmatics study that learn about mitigating devices which used to lessen the impact of the utterance. It is very useful to help people gain effectively communication.
4. The researcher hopes that this research can give contribution to the researcher and the readers to be more careful and responsible in having communication, and to the further researchers who conduct the same research. It is suggested to the next researchers to study more complete research, especially in the same field.
