## **CHAPTER I**

# **INTRODUCTION**

In this chapter the researcher presents the background of the study, formulation of the research problem, purpose of the study, hypothesis, significance of the study, scope and limitation, definition of key term, and organization of the study.

#### A. Background of the Study

Language is a tool of communication to provide an information to others. It means that humans cannot expressed an idea or knowledge if the man does not have the language. According to Fromkin (1986:3) language has very important roles in human's life, since language is the source of human life and power. Likewise with the English language, a language that has been used by many people to establish communication between countries with one another is very useful to develop a culture of each country at the international level. In Indonesia, English is one of foreign language. The application of English teaching and learning process make the teacher get many problems, because teaching English is difficult from teaching other language such as: Indonesia, Sunda, Javanese, etc. The teacher can not do that, the teaching and learning process will not run well, and the object of teaching will be difficult to be achieved. Such condition may be caused by many factors such as the media, the method, and the technique used are not appropriate and sometimes teachers just give material with conventional ways. Based on David (1991:9) vocabulary is important for the students to support their four language skills. It means that if the students master in vocabulary, it will make the students easier in learning English language. According to Thornburry (2002:114) stated that If you spend most of your time studying grammar, your English will not improve very much. You will see most improvement if you learn more words and expressions. You can say very little with grammar, but you can say almost anything with words. To teach English in the student level, besides English teacher providing material about English, the teacher should enrich the students with vocabulary. Because of vocabulary is the central of language teaching and learning, it plays an important role in the four language skills and gives contribution to the learners to perform or practice their skills better. It means that by mastering the vocabulary, the learners will able to produce so many sentences easily either in spoken or written one.

In the past, vocabulary in teaching and learning were often given little priority, but recently there has been renewed interest in the nature of vocabulary in learning and teaching. The fact shows that the learners get bored in teaching vocabulary. Teaching and learning vocabulary process is not interesting and monotonous. The teacher just force the student to memorize some words as a result, it makes student can not memorize some words well. The teacher will give punishment to the student; this way is boring method and is not good for the students' psychology. So that the using of media is needed to conduct teaching and learning process in the class. The suitable media is audio visual media because the media contains picture and voice so the students can see and hear directly such as cartoon video.

By using this media, the students are able to see the objects in the form of pictures, and the spelling of the objects name. In addition, the students are also able to listen the way to pronounce the words which they learn. As a result, they can understand and memorize the vocabularies well. Beside that, the students will be happy and they have feel enjoyable and enthusiastic to learn English vocabulary, they can catch the main message. #### **B.** Formulation of the Research Problem

 Is using Audio-Visual as media effective to teach English vocabulary at the VII <sup>C</sup> grades students of SMPN 3 Kedungwaru Tulungagung in academic year 2014/2015?

## C. Purpose of the Study

Based on formulation of the research above the main objectives of this study is:

 To find out whether there is any effectiveness using Audio-Visual as media to teach vocabulary at the VII <sup>C</sup> grades students of SMPN 3 Kedungwaru Tulungagung in academic year 2014/2015.

## **D. Hypothesis**

In this study, the hypothesis states that if T-Test score is bigger than T-Table, the alternative hypothesis (Ha) is accepted. It means that there is different score to the VII <sup>C</sup> grades before using audio-visual as media and after using audio-visual as media. The different is significant; it means that the strategy of audio-visual as media is accepted.

And then, If T-test score is similar than T-table, the null hypothesis (Ho) is rejected. It means that there is no different score to the VII <sup>C</sup> grades before using audio-visual as media and after using audio-visual as media. The different is not significant. It means that the strategy audio-visual as media is rejected.
