

## ABSTRAK

Skripsi dengan judul “**Pengaruh Pendapatan Asli Desa (PADesa), Dana Desa (DD), Alokasi Dana Desa (ADD), Dan Bagi Hasil Pajak Retribusi (BHPR) terhadap Alokasi Belanja Desa Bidang Pertanian, di Kecamatan Gondang Tahun 2016-2020**” ini ditulis oleh Sophie Miranda NIM 12402173397, Pembimbing: Wahyu Dwi Warsitasari, M.Pd.

Sektor pertanian merupakan salah satu yang bisa memberikan keuntungan di wilayah tertentu. Keberhasilan sektor pertanian tentunya tidak terlepas dari peran atau daya dukung seluruh aspek. Pendapatan Asli Desa (PADesa), Dana Desa (DD), Alokasi Dana Desa (ADD), Bagi Hasil Pajak Retribusi (BHPR) dan Jumlah Sawah merupakan aspek yang penting bagi Alokasi Belanja Desa Bidang Pertanian.

Rumusan dalam penelitian ini adalah: 1) Apakah ada pengaruh signifikan PADesa terhadap Alokasi Belanja Desa Bidang Pertanian Tahun 2016-2020 ?, 2) Apakah ada pengaruh signifikan DD terhadap alokasi belanja desa bidang pertanian?, 3) Apakah ada pengaruh signifikan ADD terhadap Alokasi Belanja Desa Bidang Pertanian?, 4) Apakah ada pengaruh signifikan BHPR terhadap Alokasi Belanja Desa Bidang Pertanian?., Tujuan penelitian ini adalah untuk mengetahui pengaruh PADesa, DD, ADD, BHPR dan Jumlah Sawah terhadap Alokasi Belanja Desa Bidang Pertanian di Kecamatan Gondang Tahun 2016-2020.

Penelitian ini menggunakan pendekatan kuantitatif dengan jenis penelitian asosiatif. Pengumpulan data melalui data primer menggunakan instrument angket. Adapun populasi dalam penelitian berjumlah 20 Desa-desa di Kecamatan Gondang. Teknik pengambilan sampel menggunakan *non probability sampling*. Teknik analisis data menggunakan uji multikolinearitas, uji simultan, uji regresi data panel, uji *chow*, uji *hausman*, uji hipotesis, dan uji asumsi klasik.

Hasil penelitian menunjukkan bahwa 1) PADesa berpengaruh positif dan signifikan terhadap alokasi belanja dibidang pertanian di kecamatan gondang. 2) DD berpengaruh positif dan signifikan terhadap alokasi belanja dibidang pertanian di kecamatan gondang. 3) ADD berpengaruh positif dan signifikan terhadap alokasi belanja dibidang pertanian di kecamatan gondang. 4) BHPR berpengaruh positif dan signifikan terhadap alokasi belanja dibidang pertanian di kecamatan gondang.

## ABSTRACT

*Thesis with the title “The effect of Village Original Income (PADesa), Village Funds (DD), Village Fund Allocation (ADD), Revenue Sharing Taxes (BHPR) on Village Expenditure Allocations in Agriculture in Gondang District 2016-2020” written by Sophie Miranda NIM 12402173397, Advisor: Wahyu Dwi Warsitasari, M.Pd.*

*The agricultural sector is one that can provide benefits in certain areas. The success of the agricultural sector certainly cannot be separated from the role or carrying capacity of all aspects. Village Original Income (PADesa), Village Funds (DD), Village Fund Allocation (ADD), Revenue Sharing Taxes (BHPR) and Total Rice Fields are important aspects for Village Expenditure Allocation for Agriculture.*

*The formulations in this research are: 1) Is there a significant effect of PADesa on Village Expenditure Allocation for Agriculture in 2016-2020?, 2) Is there a significant effect of DD on village expenditure allocation for agriculture?, 3) Is there a significant effect of ADD on Expenditure Allocation Village Agriculture Sector?, 4) Is there a significant effect of BHPR on Village Expenditure Allocation for Agriculture?, The purpose of this study was to determine the effect of PADesa, DD, ADD, BHPR and Total Rice Fields on Village Expenditure Allocation for Agriculture in Gondang District in 2016-2020.*

*This research used a quantitative approach with the type of associative research. Collecting data through primary data using a questionnaire instrument. The population in the study amounted to 20 villages in Gondang District. The sampling technique used non-probability sampling. The data analysis technique used multicollinearity test, panel data regression test, Chow test, Hausman test, hypothesis testing, and classical assumption test.*

*The results showed that 1) PADesa had a positive and significant effect on the allocation of spending in agriculture in the Gondang sub-district. 2) DD has a positive and significant effect on the allocation of spending in agriculture in the Gondang sub-district. 3) ADD has a positive and significant effect on the allocation of spending in agriculture in the Gondang sub-district. 4) BHPR has a positive and significant effect on the allocation of spending in agriculture in the Gondang sub-district.*
