CHAPTER I

INTRODUCTION

This chapter, the writer presents the research background of study that describes the reason why the writer intends to conduct the study. On the basis of the reason, formulation of problem, purpose of the study, significance of the study, and scope and limitation of the study are formulated. Definition of key term is given so that the readers are expected to have the same interpretation in understanding the study.

A. Background of the Research

According to Roman Jakobson in Cook (1989:26), language functions include expressive, directive, phatic, poetic, referential, and metalingustic function.

Understanding language functions can make our mind easily in analyzing every sentence what the speaker said when we communicate. It also will help us explain how stretches of language. Language functions can also be seen in many place, we can found in the literature. Literature is inseparable from language functions. Literature is a term used to describe written texts marked by careful use of language, including features such as creative metaphors, well-turned phrases, elegant syntax, rhyme, alliteration, which are aesthetically read or intended by the author to be aesthetically read and are deliberately somewhat open in interpretation, Mey in Meyer (1997:1). Literature is a study that concerns a whole range of human life and activities. Human life and activities has many varieties, so literature has many forms. Forms of literature are taken from human activities (spoken or written) in their daily life. According to Ade (2008:6) types of literature we mean genres of literature.

In general, there are three broad types of literature, these are drama, poetry and prose. Under drama we have: dance drama, radio and television drama, mime, pantomime, heroic and morality plays. Principally however, they all come under: tragedy, comedy, tragic-comedy and melodrama. From literature we can analyze kind of language functions are used in the types of literature.

Language function can also be seen in literacy work works, such as movie or cinema film. In this case film is included in drama. According to Cambridge Advance Learner's Dictionary (2008), film is a series of moving pictures, usually shown in a cinema or on television and often telling a story. Using movie we can learning about language are used. In the teaching and learning language, it can be used to teaching and learning language media. Study about language use a media is easier. The researcher analyzes language functions used by the main character in "12 Years a Slave" movie transcript. This film is the best film and the winner of best film categories in the 86th Academy Awards ceremony, presented by the Academy of Motion Picture Arts and Sciences (AMPAS) and took place March 2, 2014, at the Dolby Theatre in Hollywood, Los Angeles (wikipedia.org).

The study about language functions itself has been studied in UIN (*State Islamic University*) Jakarta before. Muhammad Hasits in his thesis *An Analysis of Language Functions Used by Marcus Burnett in Bad Boys II Film* (2007), his thesis emphasizes on theory of language functions by Janet Holmes. And also Agwin Degaf in his thesis *A Study of Language Functions Used by the Caretakers of Autistic Children in "Miracle Run"(2010)* studied in Maulana Malik Ibrahim State Islamic University of Malang, his thesis emphasizes on theory of language functions by M.A.K. Halliday. It's also has been studied in Universitas Brawijaya before.
