CHAPTER I

INTRODUCTION

This chapter, the researcher will be a discussion about the context of the study that describes the reason the research takes the issue; the researcher will be told or explain in the context of the analysis, focus, and formulation of the research question, purpose of the study, the significance of the study, and definition of key terms.

A. Background of the Study

A language is a set of the signals by which we communicate. Human beings are not the only species to have an elaborate communication system (Todd, 2000:6). Living things created by God have their languages. Language is a sign that is used if we want to communicate. Humans use language to share in their social environment. Each language community is different in using language, especially English.

English is an international language that is very widely used. According to Brumfit (2001:35), English is an international language that is the most widespread medium of global communication. As an international language, English is used to communicate between nations that have different languages. The first language difference will not prevent people from sharing like English. English is one of the communication tools used verbally and in writing.

English language in terms of its current role in the world, according to Hornby (2005: 506) states that "English is the language originally of England, now spoken in many other countries and is used as a language of international

communication throughout the world" basically English is the native language of English.

In Indonesia, English is a foreign language. English is the most important foreign language learned in Indonesia. English in Indonesia is generally taught as a foreign language. In an era that is increasingly making English more and more popular by people. Especially at school, at this time, there is already an English extracurricular. Meanwhile, this research discusses the portray English teaching of tutors at Fajar English Course Pare Kediri which was conducted at a course institution.

Previous research was also conducted by Gede Sutisna (2021) with the title of "Implementasi pendidikan karakter dalam belajar bahasa inggris". This research was conducted on students at school. This study discusses how character education is integrated with the English learning process. A teacher is expected to be able to insert character values in learning so that students succeed in obtaining competency targets and have a personality by the character values being taught.

The difference between previous research that has been carried out by Gede Sutisna and this research is that Sutisna's research discusses the implementation of character education in learning English which is carried out in schools. Meanwhile, this research discusses the portray English teaching of tutors at Fajar English Course Pare Kediri which was conducted at a course institution.

Previous research was also conducted by Suswati Hendriani (2015) with the title "Permasalahan guru bahasa inggris dalam mengimplementasikan kurikulum 2013 di SLTA Kabupaten Tanah Datar". This research was conducted on students at school. This study discusses the professionalism of teachers to improve student's

English learning achievement. A teacher who has an educational background and has qualified competence. Teachers must also love their profession as a teacher. Because the teacher's professionalism can make students improve their English learning achievement

The difference between previous research that has been carried out by Suswati Hendriani with this research is that Suswati's research discusses the problems of English teachers in implementing the 2013 curriculum in high school in Tanah Datar Regency which is carried out in schools. Meanwhile, this research discusses the portray English teaching of tutors at Fajar English Course Pare Kediri which was conducted at a course institution.

Previous research was also conducted by Chusnu Syarifa Diah Kusuma with the title "Pentingnya guru dalam mengembangkan minat belajar bahasa Inggris siswa". This research was conducted on students at school. This study discusses the importance of teachers to develop an interest in learning English. The teacher is considered a source of knowledge and a source of learning by students. A teacher must be prepared to accept and adapt to the various changes that occur around students.
