CHAPTER I

INTRODUCTION

A. Research Context

In the view of Islam, work is a humanitarian obligation that cannot be separated from everyday human life. Although Islamic sharia has given women complete freedom and confers the same rights as men in terms of working and earning a living. The reality is that there is a long-standing perception of society that everyone has biological attributes as a man or a man. women, which affects the differences in everyday life. Differences in biological anatomy ultimately inevitably make a difference to the role in social life.

The perception that looks down on women has determined the "appropriateness" of women to take on roles only in the domestic sector, while men take roles in the public sector. The extreme dual role in differentiating the roles of women and men has narrowed the possibilities for women to develop their potential and to participate in national development. (Fadilah Sralaga, Introduction to Gender Studies¹

In this modern era, women are not only those who are imprisoned in the house alone but also do activities outside the home to work and earn income. The entry of women into the social area is caused by various factors, including the higher education of women, thus increasing their ability to compete with men in social life, because of the desire to advance and develop, because of the demands of the times that have changed and for reasons of improving one's quality.²

A very visible reason, especially for poor families, is to get income to meet household needs. With the high awareness of women to work, even the obstacles they face are not straight and easy. In general, it is demanded that the community wants women to work to play a dual role, namely: playing a role as a worker and as a housewife.

The normative view of working women, which assumes that a woman's success is if she is successful in her job and also in raising her family, has become a common thing in our society. That is, there is still an assumption that success in the family rests on the shoulders of the mother or becomes the absolute responsibility of a woman, and is not the responsibility of men.

The family environment is the most important educational environment because, in this family, children begin to get education and guidance. if it is said that the environment is the main because most of the child's life is in the family so that the child gets a lot of education that he receives in his family.³

As for the hadith of the Prophet Muhammad. Reads:

"Indeed, in the human body there is mudhghoh, if it functions properly, then the whole body is fine, and if it is damaged, then the whole body is damaged. You know that Mudhgoh is Qolbu. (Narrated by Bukhori Muslim)⁴

From the hadith quoted above, it relates to the problem of educating children for their success, then the main thing that needs to be based on is a problem of the heart, it can also be called faith because the main location of faith is in the heart. So the main task of parents or a career woman is to teach how to cultivate, guide, lead children to train their hearts to become good personalities.

The specialty of this study with other studies is that this study is more inclined to the role of career women in support the success of children's education, while other studies are more concerned with the role of career women as housewives. as well as tips on what career women do and what factors follow in carrying out their role as educators for their children. So that's the difference between this research and previous research.

The difference in characteristics between a father and a mother in parenting is one of the factors that then raises an assumption in society that a mother who is said to be successful in carrying out her role and function can raise, guide, and educate her children to succeed in education at school They also feel that the community will reject it in social circles.⁵

Before the researchers conducted field observations, the researchers also conducted pre-observations, by asking directly the village head and village leaders who knew in more detail the residents in Serut, Boyolangu Tulungagung. the data obtained during pre-observation strongly supports the researcher in establishing which subjects are sufficient to dig up information about the role of career women in supporting the success of children's education.

The participation of women in work today does not only require equal rights with men but also states that they are actualizing themselves as human beings who benefit the family and nation. Indriyani (2009) states that women's participation

In the family sphere, the urgency of character education for children is more dominant in achieving the success of children's education, one of which is that the family is the most important vehicle for educating, caring for, socializing with children, developing the abilities of all members so that they can carry out their functions in society properly and provide satisfaction and the environment. Healthy family to achieve a prosperous family. Family is an important aspect to instill character in children so that children have good character.⁶

The researcher chose this title because the environment where the researcher lives is currently quite interesting to study, especially for the role of career women in supporting the success of children's education, because in this environment many women have dual roles as housewives and work outside the home. E.Definitions of Terms

1. Career Women

Many experts put forward the definition of a career. **Murniati** (2004: 217) defines a career as a job that provides hope for advancement. Therefore, a career is always associated with money and power.

Handoko (2001: 123) explains that a career is all jobs or positions that are handled during a person's working life. Meanwhile, Gibson (in Ghufron, 2013: 114) argues that a career is an attitude and behavior related to the experience and work activities throughout the person's life. Thus, a career shows the development of individual employees in the level of position or rank that can be achieved while working in an organization. In other words, according to Ghufron (2013: 114), careers have characteristics that require time to achieve progress. A career requires a different level of commitment and personal investment from work.

According to Sugiri, as quoted in the book by Maidi Gulton, said that: as long as the process of growth and development is still ongoing in his body, the child is still a child and only becomes an adult when the process of development and growth is complete, so the age limit of children is the same as that of beginners. become adults, which is 18 years for women and 21 years for men.¹⁰

According to Kamrani Buseri, that in the family, the development of early social attitudes takes place which will sustain the development of subsequent social attitudes. The ability to get along in the family environment underlies a wider ability to socialize. In these social relationships, children will understand how to respect others, know how to communicate with others, and understand that their freedom is limited by the freedom of others.¹¹
