Penelitian ini di latar belakang oleh adanya praktik yang dilakukan oleh indomaret di Desa Gondang Kecamatan Gondang Kabupaten Tulungagung terdapat kejanggalan dalam praktik jual belinya pada saat pembeli ingin membeli minyak goreng di toko tersebut pihak pembeli diwajibkan juga membeli barang lain sebagai pendamping minyak tersebut. Minyak goreng merupakan kebutuhan sehari-hari yang selalu dibutuhkan pembeli maka dengan terpaksa pembeli membeli minyak tersebut dengan syarat membeli barang lainnya yang belum tentu dibutuhkan. Praktik tersebut berlangsung sejak awal tahun 2022 tepatnya ketika kondisi pasar sedang dalam kelangkaan minyak goreng.

Rumusan masalah penelitian ini adalah: 1) Bagaimana praktik jual beli minyak goreng bersyarat di Indomaret di desa Gondang Kecamatan Gondang Kabupaten Tulungagung? 2) Bagaimana tinjauan hukum islam terhadap praktik jual beli minyak goreng bersyarat dengan barang lain di Indomaret di desa Gondang Kecamatan Gondang Kabupaten Tulungagung?

Jenis penelitian yang akan digunakan adalah penelitian lapangan (*field research*), teknik pengumpulan data yang digunakan adalah Observasi, Wawancara, dan Dokumentasi, sedangkan teknik analisis data yang digunakan adalah Reduksi Data, Penyajian Data, dan Penarikan Kesimpulan.

Hasil dari penelitian ini menunjukkan bahwa: 1) Praktik jual beli minyak goreng dengan sistem bersyarat yang terjadi di Indomaret di Desa Gondang Kecamatan Gondang Kabupaten Tulungagung terjadi karena adanya kelangkaan minyak goreng sejak awal bulan tahun 2022 dan masih tetap dilakukan meskipun banyak pihak pembeli yang dirugikan. 2) Di tinjau dari hukum Islam praktik jual beli minyak goreng bersyarat dengan barang lain yang dilakukan di Indomaret di Desa Gondang Kecamatan Gondang Kabupaten Tulungagung dijelaskan bahwa termasuk ke dalam jual beli yang sah, karena secara keseluruhan telah memenuhi syarat yaitu terdapat pihak yang melakukan jual beli, dan pembeli memiliki kebebasan untuk melanjutkan atau tidak melanjutkan jual beli secara bersyarat tersebut.

This research is motivated by a practice carried out by Indomaret in Gondang Village, Gondang District, Tulungagung Regency, where there are irregularities in the practice of buying and selling when a buyer wants to buy cooking oil at the shop, the buyer is also required to buy other goods to accompany the oil. Cooking oil is a daily necessity that is always needed by buyers, so buyers are forced to buy this oil with the condition that they buy other goods that are not necessarily needed. This practice has been going on since early 2022, when market conditions were in the midst of a scarcity of cooking oil.

The formulation of the research problem is: 1) What is the practice of buying and selling conditional cooking oil at Indomaret in Gondang village, Gondang District, Tulungagung Regency? 2) What is the review of Islamic law on the practice of buying and selling conditional cooking oil with other goods at Indomaret in Gondang village, Gondang District, Tulungagung Regency?

The type of research that will be used is field research, the data collection techniques used are observation, interviews, and documentation, while the data analysis techniques used are data reduction, data presentation, and conclusion drawing.

The results of this study indicate that: 1) The practice of buying and selling cooking oil under a conditional system that occurred at Indomaret in Gondang Village, Gondang District, Tulungagung Regency, occurred due to a shortage of cooking oil since the beginning of 2022 and is still being carried out even though many buyers have suffered losses. 2) In view of Islamic law the practice of conditional sale and purchase of cooking oil with other goods carried out at Indomaret in Gondang Village, Gondang District, Tulungagung Regency, it is explained that it is included in a legitimate sale and purchase, because as a whole it has fulfilled the requirements, that is, there are parties who make the sale and purchase , and the buyer has the freedom to continue or not continue the sale and purchase conditionally.
