

ABSTRAK

Skripsi dengan judul “Pengaruh Bimbingan Teknis, Kompetensi Perangkat Desa dan Kemampuan Pengoperasian Komputer terhadap Efektivitas Penerapan Aplikasi SISKEUDES di Kecamatan Besuk Kabupaten Probolinggo” ini ditulis oleh Raudatul Karomah, NIM. 12403193239 dengan dosen pembimbing Firda Zulfa Fahriani, M. Sy.

Penelitian ini dilatarbelakangi oleh temuan peneliti tentang informasi adanya keterlambatan proses pencairan dana desa dikarenakan belum menginput berkas persyaratan ke aplikasi SISKEUDES, sehingga terancam tidak mendapatkan dana desa. Hal ini berhubungan dengan efektivitas penggunaan SISKEUDES serta pentingnya menerapkan aplikasi tersebut dalam membantu pengelolaan keuangan desa.

Penelitian ini bertujuan untuk menguji dan menganalisis pengaruh bimbingan teknis, kompetensi perangkat desa dan kemampuan pengoperasian komputer terhadap efektivitas penerapan aplikasi SISKEUDES di Kecamatan Besuk Kabupaten Probolinggo.

Penelitian ini menggunakan pendekatan kuantitatif dengan jenis penelitian asosiatif. Teknik pengumpulan sampel menggunakan metode *purposive sampling* dan diperoleh sampel sebanyak 68 responden. Data yang digunakan merupakan data primer yang diperoleh dari menyebarkan kuesioner. Metode analisis data menggunakan analisis statistik deskriptif, uji kualitas data, uji asumsi klasik, analisis regresi linier berganda, uji hipotesis, serta uji koefisien determinasi.

Hasil penelitian menunjukkan bahwa bimbingan teknis dan kompetensi perangkat desa berpengaruh positif dan signifikan terhadap efektivitas penerapan aplikasi SISKEUDES. Sedangkan kemampuan pengoperasian komputer tidak berpengaruh terhadap efektivitas penerapan aplikasi SISKEUDES. Bimbingan teknis, kompetensi perangkat desa dan kemampuan pengoperasian komputer secara simultan berpengaruh positif dan signifikan terhadap efektivitas penerapan aplikasi SISKEUDES.

ABSTRACT

The thesis with the title “The Effect of Technical Guidance, Village Apparatus Competence, and Computer Operating Ability on the Effectiveness of the Application of SISKEUDES in Besuk District, Probolinggo Regency” was written by Raudatul Karomah, NIM. 12403193239 with supervisor Firda Zulfa Fahriani M. Sy.

This study is motivated by the findings of researchers about the information on the delay in the process of disbursing village funds because they have not inputted the required files into the SISKEUDES application, so they are under threat of not getting village funds. This relates to the effectiveness of using SISKEUDES and the importance of implementing the application in assisting village financial management.

This study aims to test and analyze the effect of technical guidance, the competence of village officials, and the ability to operate computers on the SISKEUDES application's effectiveness in Besuk District, Probolinggo Regency.

This research uses a quantitative approach with an associative research type. The sample collection technique used a purposive sampling method and obtained a sample of 68 respondents. The data used are primary data obtained from distributing questionnaires. The data analysis method uses descriptive statistical analysis, data quality test, classical assumption test, multiple linear regression analysis, hypothesis testing, and determination coefficient test.

The results showed that technical guidance and the competence of village officials had a positive and significant effect on the effectiveness of the implementation of the SISKEUDES application. Meanwhile, computer operating skills do not affect the effectiveness of implementing the Siskeudes application. Technical guidance, the competence of village officials, and computer operating skills simultaneously have a positive and significant effect on the SISKEUDES application's effectiveness.
