Penelitian ini dilator belakangi oleh banyaknya masyarakat miskin di desa Jarakan. Oleh sebab itu maka menjadi tugas dari pemerintah desa bagaimana cara dalam mengatasi dan mengentaskan kemiskinan masyarakat desa. Fokus penelitian ini yaitu: 1). Bagaimana Pengelolaan Dana Desa Terhadap Pengentasan Kemiskinan Masyarakat Desa Jarakan Kecamatan Gondang Kabupaten Tulungagung? 2). Bagaimana Implementasi Dana Desa Terhadap Pengentasan Kemiskinan Masyarakat Desa Jarakan Kecamatan Gondang Kabupaten Tulungagung? 3). Bagaimana Efektivitas Dana Desa Terhadap Pengentasan Kemiskinan Masyarakat Desa Jarakan Kecamatan Gondang Kabupaten Tulungagung?.

Penelitian ini menggunakan jenis penelitian kualitatif dengan pendekatan studi kasus, sumber data yang diperoleh dari informasi, situasi lokasi, dan berkas dokumentasi. Teknik pengumpulan data dengan wawancara, observasi, dan dokumentasi serta menggunakan teknik analisis data dan pengecekan keabsahan temuan.

Hasil penelitian ini adalah sebagai berikut: 1) Pengelolaan Dana Desa Terhadap Pengentasan Kemiskinan Masyarakat Desa Jarakan adalah upaya pemerintah desa dalam menentukan siapa saja masyarakat yang dianggap kurang mampu dan berhak mendapatkan bantuan dari pemerintah 2). Implementasi pengelolaan dana desa terhadap pengentasan kemiskinan masyarakat desa adalah pemberian dana berupa BLT (Bantuan Tunai Langsung) kepada masyarakat miskin dengan penyaluran dana dilakukan secara serentak di balai desa.3). Efektivitas pengelolaan dana desa terhadap pengentasan kemiskinan masyarakat desa Jarakan adalah pemberian dana bantuan berupa BLT (Bantuan Langsung Tunai) ini dianggap dapat membantu perekonomian masyarakat dalam pemenuhan kebutuhan sehari-hari.

ABSTRACT

The thesis entitled "Effectiveness of Village Fund Management Against Poverty Alleviation of the Distance Village Community, Gondang District, Tulungagung Regency" was written by Lely Ludnama Dewi, NIM. 12402173223 Supervisor Moh. Rois Abin, M. Pd.

This research is motivated by the large number of poor people in the village of Tutupan. Therefore, it is the duty of the village government how to overcome and alleviate poverty in rural communities. The focus of this research are: 1). How is the Management of Village Funds Against Poverty Alleviation of the Village Community of Jauhan, Gondang District, Tulungagung Regency? 2). How is the Implementation of Village Funds Against Poverty Alleviation of the Village Community of Jauhan, Gondang District, Tulungagung Regency? 3). How is the Effectiveness of Village Funds Against Poverty Alleviation of the Village Community of Jangkaan Village, Gondang District, Tulungagung Regency?.

This research uses qualitative research with a case study approach, data sources obtained from information, location situations, and documentation files. Data collection techniques are interviews, observations, and documentation as well as using data analysis techniques and checking the validity of the findings.

The results of this study are as follows: 1) Management of Village Funds Against Poverty Alleviation of the Distance Community Village is an effort by the village government in determining who the community is considered underprivileged and entitled to assistance from the government 2). The implementation of village fund management for poverty alleviation in rural communities is the provision of funds in the form of BLT (Direct Cash Assistance) to the poor with the distribution of funds carried out simultaneously at the village hall. 3). The effectiveness of the management of village funds on poverty alleviation for the communities of the Jangkaan village is that the provision of assistance funds in the form of BLT (Direct Cash Assistance) is considered to be able to help the community's economy in meeting daily needs.
