

CHAPTER VI

CONCLUSION AND SUGGESTION

This chapter present about the conclusion of this research and also the suggestion. Conclusion means summarize the result of the study based on the research problems that has been proposed. So here, the researcher summarize the deixis types and also the meaning or referents of each deixis types as generally which were found in President Barack Obama debate speech in The Second Presidential Election Debate versus Governor Mitt Romney in October 16th, 2012. While in suggestion, the researcher give some recommendation be based on the result of this study for better result in learning deixis in daily activities, public speech, and especially in debate speech.

A. Conclusion

Based on the research problems such as explained before and also the research findings, the researcher can conclude this research follows:

1. Here the researcher has found the types of deixis used in President Barack Obama debate speech in The Second Presidential Election Debate versus Governor Mitt Romney on October 16th, 2012. And there are three basic types found, they are:
 - a. Person deixis which used by President Barack Obama in his debate speech which presented by the using of some words are following:

I, we, our, my, me, us, you, your, yours, yourself, he, his, she, her, herself, they, their, them, and themselves.

- b. Place deixis found which are presented by following the words: *here, there, out there, that, this, these, those, in war theater, and on the streets.*
 - c. Time deixis found which are presented by following the words: *now, right now, tomorrow, then, during, today, the future, the last decade, in decades, the next day, two weeks ago, the next four years, etc.*
2. Next, the researcher conclude meaning or referents of each deixis types used by President Barack Obama in his debate speech, which can be described as follows:
- a. Person deixis, such as be based on the finding of this research, it refers or has the function to indicate such kind of person. It can be the speaker himself or the speaker with other which included as the first person deixis, then someone or people who invited by the speaker to talk with him which included as second person deixis, and also can be refers to someone or some person that are spoken by the speaker which included as third person deixis.
 - b. Place deixis found in this research refers or has the meaning to point the specific place based on the context shown by the speaker. It can be the place that near from speaker, for examples such United States as the country where President Barack Obama live and as the place

where those election debate was being held. It also can be the place that away from speaker, for examples such in Benghazi, Libya or other countries outside of United States.

- c. Time deixis found in this research has the meaning to indicate or point the specific time based on the context shown by speaker. It can be the time before or when the speech event happens, even after the speech event happens. It also indicate the time that short or near from speaker which sometimes called as proximal term and the specific time that away from speaker which sometimes called as distal term.

B. Suggestion

The researcher believe that this study may help the readers to enrich their knowledge about deixis as one of the field in pragmatics study. So here, the researcher suggest to the reader or whoever read this thesis (can be lecturer or teacher, student, even the next researcher) to read carefully, so they can get more knowledge about deixis deeply. They can enrich the knowledge in understanding about the theories deixis, also about the deixis types, how to use it, even how to interpret or extract the meaning of each deixis in the right way.

The researcher also believe that in conducting this research, it is far away from the word perfect and maybe still there are some mistakes in writing. Therefore, because this is also qualitative research that have ongoing characteristic or continuity, the researcher suggests to the next researcher to enrich the knowledge about the theories of deixis, read more book or more

previous study such as journal, use the better data resources, and also used better method which appropriate toward the research problems and the researcher themselves, thus they can conducting the better research which in the next time may be the better reference to the next researchers.
