

## ABSTRAK

Skripsi dengan judul “Pengaruh *Return On Asset* (ROA), *Return On Equity* (ROE), *Debt to Equity Ratio* (DER) dan *Earning Per Share* (EPS) terhadap Harga Saham Perusahaan Tambang yang Terdaftar di Bursa Efek Indonesia Periode 2019-2022” yang ditulis oleh Siti Latifatul Ulfa, NIM. 126406202192, Jurusan Bisnis dan Manajemen, Prodi Manajemen Keuangan Syariah Fakultas Ekonomi dan Bisnis Islam dengan pembimbing Nadia Roosmalita Sari, S.P.d., M.Kom.

Harga saham bersifat fluktuatif sesuai dengan tingkat permintaan dan penawaran. Perusahaan sering menghadapi tantangan yang kompleks dalam menjaga stabilitas harga saham. Sedangkan investor perlu memperhatikan kinerja perusahaan yang dilihat dari rasio-rasio keuangan selama periode tertentu yang mencerminkan informasi berkaitan dengan perkembangan keuangan perusahaan bersifat jangka panjang. Tujuan penelitian ini adalah (1) untuk menguji pengaruh *Return On Asset*, *Return On Equity*, *Debt to Equity Ratio* dan *Earning Per Share* secara simultan terhadap harga saham perusahaan sektor tambang, (2) untuk menguji pengaruh *Return On Asset* terhadap harga saham perusahaan sektor tambang, (3) untuk menguji pengaruh *Return On Equity* terhadap harga saham perusahaan sektor tambang, (4) untuk menguji pengaruh *Debt to Equity Ratio* terhadap harga saham perusahaan sektor tambang, (5) untuk menguji pengaruh *Earning Per Share* terhadap harga saham perusahaan sektor tambang.

Penelitian ini menggunakan metode kuantitatif. Sumber data penelitian yang digunakan adalah data sekunder yang diambil dari website resmi perusahaan terkait serta Bursa Efek Indonesia dalam kurun waktu 2019-2022. Pengolahan data dalam penelitian ini menggunakan *Eviews* 12 serta menggunakan teknik analisis regresi data panel.

Hasil penelitian ini menunjukkan bahwa (1) Secara simultan variabel *Return On Asset*, *Return On Equity*, *Debt to Equity Ratio* dan *Earning Per Share* berpengaruh signifikan dan positif terhadap harga saham perusahaan sektor tambang, (2) *Return On Asset* berpengaruh positif terhadap harga saham perusahaan sektor tambang, (3) *Return On Equity* berpengaruh positif terhadap harga saham perusahaan sektor tambang, (4) *Debt to Equity Ratio* tidak berpengaruh terhadap harga saham perusahaan sektor tambang, (5) *Earning Per Share* tidak berpengaruh terhadap harga saham perusahaan sektor tambang.

## ABSTRACT

*Thesis with the title "The Influence of Return On Assets (ROA), Return On Equity (ROE), Debt to Equity Ratio (DER) and Earning Per Share (EPS) on the Share Prices of Mining Companies Listed on the Indonesian Stock Exchange for the 2019-2022 Period" which written by Siti Latifatul Ulfah, NIM. 126406202192, Department of Business and Management, Sharia Financial Management Study Program, Faculty of Islamic Economics and Business with supervisor Nadia Roosmalita Sari, S.P.d., M.Kom.*

*Share prices fluctuate according to the level of supply and demand. Companies often face complex challenges in maintaining share price stability. Meanwhile, investors need to pay attention to the company's performance as seen from financial ratios during a certain period which reflect information relating to the company's long-term financial development. The aims of this research are (1) to test the influence of Return On Assets, Return On Equity, Debt to Equity Ratio and Earning Per Share simultaneously on share prices of mining sector companies, (2) to test the influence of Return On Assets on share prices of mining sector companies , (3) to test the effect of Return On Equity on share prices of mining sector companies, (4) to test the effect of Debt to Equity Ratio on share prices of mining sector companies, (5) to test the effect of Earning Per Share on share prices of mining sector companies.*

*This research uses quantitative methods. The research data source used is secondary data taken from the official website of the relevant company and the Indonesian Stock Exchange in the 2019-2022 period. Data processing in this research uses Eviews 12 and uses panel data regression analysis techniques.*

*The results of this research show that (1) Simultaneously the variables Return On Assets, Return On Equity, Debt to Equity Ratio and Earning Per Share have a significant and positive effect on share prices of mining sector companies, (2) Return On Assets have a positive effect on company share prices mining sector, (3) Return On Equity has a positive effect on share prices of mining sector companies, (4) Debt to Equity Ratio has no effect on share prices of mining sector companies, (5) Earning Per Share has no effect on share prices of mining sector companies.*
