

## ABSTRAK

Skripsi dengan judul “Efektivitas Pengelolaan Dana Desa Guna Meningkatkan Pembangunan dan Pemberdayaan Masyarakat Desa Timahan Kecamatan Kampak Kabupaten Trenggalek” ini ditulis oleh Dyah Zulfa Rusydiana, NIM. 126403202072 dengan dosen pembimbing Dyah Pravitasari S.E, M.S.A.

Desa seringkali diidentikan dengan daerah tertinggal baik dari infrastruktur maupun sumber daya manusianya. Dana desa diberikan sebagai dana perangsang untuk mendorong dalam pendanaan program pemerintah desa yang diprioritaskan untuk pembangunan desa dan pemberdayaan masyarakat. Seluruh proses pengelolaan dana desa disesuaikan dengan peraturan berlaku serta melibatkan masyarakat agar efektivitas pengelolaan dana desa dapat dilakukan secara maksimal, sehingga semakin banyak program dari pengelolaan dana desa yang terealisasi maka akan semakin efektif pengelolaannya.

Tujuan Penelitian ini, yaitu: (1) mendeskripsikan pengelolaan dana desa guna meningkatkan pembangunan dan pemberdayaan masyarakat Desa Timahan; (2) mendeskripsikan pembangunan dan pemberdayaan masyarakat Desa Timahan; (3) mengidentifikasi kendala dan solusi pengelolaan dana desa guna meningkatkan pembangunan dan pemberdayaan masyarakat Desa Timahan.

Metode yang dipergunakan pada penelitian ini yaitu pendekatan kualitatif berjenis penelitian studi lapangan. Adapun jenis data pada penelitian dibagi jadi 2 yaitu data primer serta sekunder. Data primer didapatkan dengan melakukan observasi serta wawancara dilokasi penelitian. Data sekunder didapatkan dari dokumen seperti Peraturan Desa. Metode pengumpulan data dengan cara observasi, wawancara, dan dokumentasi.

Hasil penelitian yang didapatkan pada penelitian ini disimpulkan bahwa (1) pengelolaan dana desa guna meningkatkan pembangunan dan pemberdayaan masyarakat Desa Timahan yang dijalankan berdasarkan Permendagri No. 20 Tahun 2018 tentang pengelolaan keuangan desa meliputi perencanaan, pelaksanaan, penatausahaan, pelaporan, dan pertanggungjawaban sudah berjalan efektif. (2) Pembangunan dan pemberdayaan masyarakat Desa Timahan berdasarkan Undang-Undang No. 6 Tahun 2014 tentang desa meliputi perencanaan, pelaksanaan dan pengawasan sudah berjalan efektif. (3) Kendala pengelolaan dana desa guna meningkatkan pembangunan dan pemberdayaan masyarakat Desa Timahan yakni perubahan regulasi tiap tahun dan kurangnya pemahaman masyarakat. Solusinya adalah perangkat desa menyesuaikan dengan cepat regulasi terbaru, serta memberikan pemahaman kepada masyarakat terkait pengelolaan dana desa dan pembangunan desa dengan mengadakan sosialisasi, pelatihan atau *workshop*.

## **ABSTRACT**

*The thesis with the title "Effectiveness of Village Fund Management to Improve Community Development and Empowerment in Timahan Village, Kampak District, Trenggalek Regency" was written by Dyah Zulfa Rusydiana, NIM. 126403202072 with supervisor Dyah Pravitasari S. E, M.S.A.*

*Villages are often identified as underdeveloped areas both in terms of infrastructure and human resources. Village funds are provided as stimulant funds to encourage village government funding programs that prioritize village development and community empowerment. The entire village fund management process is adjusted to applicable regulations and involves the community so that the effectiveness of village fund management can be carried out optimally, so that the more village fund management programs that are realized, the more effective the management will be.*

*The objectives of this research are: (1) to describe the management of village funds to improve development and empowerment of the Timahan Village community; (2) describe the development and empowerment of the Timahan Village community; (3) identifying obstacles and solutions for managing village funds to improve development and empowerment of the Timahan Village community.*

*The method used in this research is a qualitative approach in the form of field study research. The types of data in research are divided into 2, namely primary and secondary data. Primary data was obtained by conducting observations and interviews at the research location. Secondary data was obtained from documents such as Village Regulations. Data collection methods include observation, interviews and documentation.*

*The research results obtained in this study concluded that (1) the management of village funds to improve development and empowerment of the Timahan Village community was carried out based on Permendagri No. 20 of 2018 concerning village financial management including planning, implementation, administration, reporting and accountability has been running effectively. (2) Development and empowerment of the Timahan Village community based on Law no. 6 of 2014 concerning villages including planning, implementation and supervision has been effective. (3) Obstacles in managing village funds to increase development and empowerment of the Timahan Village community are changes in regulations every year and lack of community understanding. The solution is for village officials to quickly adapt to the latest regulations, as well as provide understanding to the community regarding village fund management and village development by holding outreach, training or workshops.*
