

ABSTRAK

Skripsi dengan judul “Pengaruh Program Relawan Pajak, Pelatihan Pajak dan Pemahaman Pajak Terhadap Minat Mahasiswa Berkariir di Bidang Perpajakan (Studi pada Relawan Pajak UIN Sayyid Ali Rahmatullah Tulungagung)” yang ditulis Angellina Febriani, NIM 126403202108, pembimbing Dr. Lantip Susilowati, S.Pd., M.M.

Penelitian ini bertujuan (1) Untuk meneliti pengaruh adanya program Relawan Pajak, pelatihan pajak, dan pemahaman pajak terhadap minat mahasiswa berkariir di bidang Perpajakan. (2) Untuk meneliti pengaruh adanya program relawan pajak terhadap minat mahasiswa untuk berkariir di bidang perpajakan. (3) Untuk meneliti pengaruh adanya pelatihan pajak terhadap minat mahasiswa untuk berkariir di bidang perpajakan. (4) Untuk meneliti pengaruh pemahaman terhadap minat mahasiswa untuk berkariir di bidang perpajakan.

Penelitian ini menggunakan pendekatan kuantitatif dengan data primer. Pengumpulan data menggunakan angket atau kuisioner melalui google form. Pengambilan sampel menggunakan teknik sampel jenuh dengan jumlah sampel sebanyak 50 responden. Pengukuran dalam penelitian ini menggunakan skala likert. Metode analisis data yang digunakan adalah analisis regresi linear berganda untuk membuktikan hipotesis penelitian.

Hasil penelitian ini menunjukkan bahwa (1) program Relawan Pajak, pelatihan pajak, dan pemahaman pajak secara bersama-sama berpengaruh positif signifikan terhadap minat mahasiswa berkariir di bidang perpajakan. (2) program Relawan Pajak berpengaruh positif signifikan terhadap minat mahasiswa berkariir di bidang perpajakan. (3) pelatihan pajak berpengaruh positif signifikan terhadap minat mahasiswa berkariir di bidang

perpajakan. (4) pemahaman pajak berpengaruh positif signifikan terhadap minat mahasiswa berkarir di bidang perpajakan.

This research aims (1) To examine the influence of the Tax Volunteer program, tax training, and tax understanding on students' interest in pursuing a career in the field of Taxation. (2) To examine the influence of the tax volunteer program on students' interest in pursuing a career in the field of Taxation. (3) To examine the effect of tax training on students' interest in pursuing a career in the field of Taxation. (4) To examine the influence of understanding on students' interest in pursuing a career in the field of Taxation.

This research uses a quantitative approach with primary data. Data collection uses questionnaires or questionnaires via Google Form. Sampling used a saturated sampling technique with a sample size of 50 respondents. Measurements in this study used a Likert scale. The data analysis method used is multiple linear regression analysis to prove the research hypothesis.

The results of this research show that (1) the Tax Volunteer program, tax training, and tax understanding together have a significant positive effect on students' interest in pursuing a career in taxation. (2) the Tax Volunteer program has a significant positive effect on students' interest in pursuing a career in taxation. (3) tax training has a significant positive effect on students' interest in pursuing a career in taxation. (4) understanding taxes has a significant positive effect on students' interest in pursuing a career in taxation.
