Fairclough's theory assumes that language is not neutral and is always related to certain powers and ideologies that exist in society.

In CDA research, analysis is carried out on the way's speakers use language to build self-image and create impressions on the public. The researcher will find out how the choice of words, phrases, or the style of speech chosen can help promote certain ideas or goals.

1. What the discourse analysis are found in the speech of MOE FY 2019 Committee of Supply debate response by minister for Education Ong Ye Kung?

1. Speech as Discourse

Delivering a speech requires a language order while language as a form of social practice is determined by social structures. According to Fairclough (1995:

6) that language can be assessed as an action in this case everything that is written and stated such as asking, asserting, warning on a different plane, referring to people or things, presupposing the existence of people or things or the truth of propositions, and implicating meanings which are not overtly expressed.

2. Discourse Practice

Discourse analysis cannot be separated from linguistics according to Fairclough (1995: 4) a way to convey aspects of life including, processes, relationships and structures of the material world, the mental world of thoughts, feelings, beliefs, and so on.

Discourse has another perspective or is described between human relations and their respective worlds in this case to see a discourse requires the social structure in which they are located. Critical discourse analysis emphasizes that sees a language when it is produced. It is assumed that language is a tool for certain motives and goals in practice, one of which is the practice of power.

3. Critical Discourse Analyze

Critical Discourse Analysis according to Fairclough (1995:70 takes a text analysis approach that aims to reveal power and ideology in language and text. It asserts that language and text not only reflect social reality and power, but also create it and shape it. Therefore, critical discourse analysis highlights how language is used to reinforce and maintain social hierarchies and power.

In critical discourse analysis, Fairclough emphasizes the importance of paying attention to conflicts and tensions in language and texts. He also emphasizes the importance of understanding how language is used to reinforce power inequalities and how we can change this through better understanding and language skills.

4. Discourse and Change of Education System

The use of certain language chosen by a speaker or writer to influence the views or understanding of others about a particular topic or issue is called discourse. According to Fairclough (1995: 24) discourse includes not only the words used, but also the way the language is used, the context, and the norms and values underlying the use of the language. Discourse is often used to influence other people's opinions and views on a particular topic or issue, as well as to influence

behavior or actions taken on that topic or issue.

According to A Vic Kelly (2004:1) Changes in the education system refer to the process or results of changes that occur in the education system, both at the national and international levels. Changes in the education system can include changes in curriculum, teaching methods, use of technology, and evaluation strategies. These changes are made to improve the quality of education, the relevance of education to the demands of the Changes in the education system can be made by the government, educational institutions or communities. The change process may involve regulatory updates, curriculum reform, teacher training, educational technology development, as well as support from the community and other stakeholders. The main objectives of changes in the education system are to improve the quality and relevance of education and to correct gaps or inequalities in education access and outcomes.
