

## ABSTRAK

Skripsi dengan “Judul Pengaruh *Return On Asset, Return On Equity, Earning Per Share Dan Price To Book Value* Terhadap Harga Saham PT. Indo Tambangraya Megah Tbk. Tahun 2016 – 2023” yang ditulis oleh Ryan Tahta Sadewa, NIM. 126406202183, Pembimbing Dr. Mashudi, M. Pd. I.

Penelitian ini dilatar belakangi oleh perkembangan Harga Saham suatu Perusahaan PT. Indo Tambangraya Megah Tbk tahun 2016-2023 yang dipengaruhi oleh rasio-rasio keuangan seperti rasio *Return On Asset, Return On Equity, Earning Per Share* dan *Price to Book Value*. Sehingga dapat menjadikan terjadi nya fluktuasi pada harga saham suatu perusahaan.

Tujuan penelitian ini yaitu : 1) Untuk mengetahui adakah pengaruh secara parsial yang signifikan dari variabel *Return On Asset* terhadap Harga Saham PT. Indo Tambangraya Megah Tbk. 2) Untuk mengetahui pengaruh secara signifikan *Return On Equity* terhadap Harga Saham PT. Indo Tambangraya Megah Tbk. 3) Untuk mengetahui pengaruh secara signifikan *Earning Per Share* terhadap Harga Saham PT. Indo Tambangraya Megah Tbk. 4) Untuk mengetahui pengaruh secara signifikan *Price to Book Value* terhadap Harga Saham PT. Indo Tambangraya Megah Tbk. 5) Untuk mengetahui pengaruh signifikan secara simultan variabel *Return On Asset, Return On Equity, Earning Per Share* dan *Price to Book Value* terhadap Harga Saham PT. Indo Tambangraya Megah Tbk.

Penelitian ini menggunakan pendekatan kuantitatif dengan jenis penelitian asosiatif. Populasi yang digunakan dalam penelitian ini yaitu data triwulan perusahaan PT. Indo Tambangraya Megah Tbk. tahun 2016-2022. Dengan menggunakan teknik *purposivesampling*, sehingga menghasilkan sampel sebanyak 32 data triwulan dari 8 tahun. Sumber data yang digunakan yaitu data sekunder berupa laporan keuangan perusahaan, serta teknik pengumpulan data menggunakan metode studi dokumentasi. Penelitian ini menggunakan data sekunder yang diambil dari website [www.idx.co.id](http://www.idx.co.id), yaitu dari harga saham perusahaan yang termasuk dalam Bursa Efek Indonesia dan analisis yang digunakan regresi linier berganda dengan *software SPSS 26*.

Hasil penelitian ini menunjukan bahwa: 1) Secara parsial variabel *Return On Asset* berpengaruh positif signifikan terhadap Harga Saham PT. Indo Tambangraya Megah Tbk. 2) Secara parsial *Return On Equity* tidak berpengaruh signifikan terhadap Harga Saham PT. Indo Tambangraya Megah Tbk. 3) Secara parsial *Earning Per Share* berpengaruh positif signifikan terhadap Harga Saham PT. Indo Tambangraya Megah Tbk. 4) Secara parsial *Price to Book Value* berpengaruh positif signifikan terhadap Harga Saham PT. Indo Tambangraya Megah Tbk. 5) Secara Bersama Simultan *Return On Asset, Return On Equity, Earning Per Share* dan *Price to Book Value* berpengaruh positif signifikan terhadap Harga Saham PT. Indo Tambangraya Megah Tbk.

## ABSTRACT

*This research is motivated by the development of the share price of a PT company. Indo Tambangraya Megah Tbk 2016-2023 which is influenced by financial ratios such as Return On Assets, Return On Equity, Earning Per Share and Price to Book Value ratios. This can cause fluctuations in the share price of a company.*

*The objectives of this research are: 1) To find out whether there is a significant partial influence of the Return On Asset variable on PT Share Prices. Indo Tambangraya Megah Tbk. 2) To determine the significant influence of Return On Equity on PT Share Prices. Indo Tambangraya Megah Tbk. 3) To determine the significant influence of Earning Per Share on the Share Price of PT. Indo Tambangraya Megah Tbk. 4) To determine the significant influence of Price to Book Value on the Share Price of PT. Indo Tambangraya Megah Tbk. 5) To determine the simultaneous significant influence of the variables Return On Assets, Return On Equity, Earning Per Share and Price to Book Value on the Share Price of PT. Indo Tambangraya Megah Tbk.*

*This research uses a quantitative approach with an associative type of research. The population used in this research is quarterly data from the company PT. Indo Tambangraya Megah Tbk. 2016-2022. By using a purposive sampling technique, this resulted in a sample of 32 quarterly data from 8 years. The data sources used are secondary data in the form of company financial reports, as well as data collection techniques using the documentation study method. This research uses secondary data taken from the website www.idx.co.id, namely from the share prices of companies included in the Indonesian Stock Exchange and the analysis uses multiple linear regression with SPSS 26 software.*

*The results of this research show that: 1) Partially the Return On Asset variable has a significant positive effect on the PT share price. Indo Tambangraya Megah Tbk. 2) Partially Return On Equity has no significant effect on PT's share price. Indo Tambangraya Megah Tbk. 3) Partially, Earning Per Share has a significant positive effect on PT's share price. Indo Tambangraya Megah Tbk. 4) Partially, Price to Book Value has a significant positive effect on PT's share price. Indo Tambangraya Megah Tbk. 5) Simultaneously Return On Assets, Return On Equity, Earning Per Share and Price to Book Value have a significant positive effect on PT's share price. Indo Tambangraya Megah Tbk.*
