

## ABSTRAK

Skripsi berjudul “Pengaruh *Earning Per Share*, *Return On Assets*, *Return On Equity*, Dan *Dividen Payout Ratio* Terhadap Harga Saham Pada Perusahaan Manufaktur Yang Terdaftar Di Bursa Efek Indonesia Periode 2019 -2023” yang ditulis oleh Maya Widya Putri, NIM. 126406202144, pembimbing Amalia Nuril Hidayati, S.E., M.Sy.

Penelitian ini di latarbelakangi oleh pertumbuhan harga saham yang dapat dipengaruhi oleh kinerja keuangan Perusahaan seperti faktor internal berupa laporan keuangan *Earning Per Share*, *Return On asset*, *Return On Equity*, dan *Dividen Payout Ratio*, dengan adanya perkembangan laporan keuangan dapat mempengaruhi fluktuasi harga saham Perusahaan manufaktur sub sektor makanan dan minuman yang terdaftar di bursa efek Indonesia.

Tujuan penelitian ini yaitu : 1) Untuk mengetahui adakah pengaruh yang signifikan variabel *Earning Per Share* Terhadap Harga Saham Perusahaan manufaktur sub sektor makanan dan minuman. 2) Untuk mengetahui pengaruh secara signifikan variabel *Return On Asset* Terhadap Harga Saham Perusahaan manufaktur sub sektor makanan dan minuman. 3) Untuk mengetahui pengaruh secara signifikan variabel *Return On Equity* Terhadap Harga Saham Perusahaan manufaktur sub sektor makanan dan minuman. 4) Untuk mengetahui pengaruh secara signifikan variabel *Dividen Payout Ratio* Terhadap Harga Saham Perusahaan manufaktur sub sektor makanan dan minuman. 5) Untuk mengetahui pengaruh signifikan secara simultan variabel *Earning Per Share*, *Return On Asset*, *Return On equity*, dan *Dividen Payout Ratio* Terhadap Harga Saham Perusahaan manufaktur sub sektor makanan dan minuman.

Penelitian ini menggunakan pendekatan kuantitatif dengan jenis penelitian asosiatif. Populasi yang digunakan dalam penelitian ini yaitu data triwulan perusahaan manufaktur sub sektor makanan dan minuman yang terdaftar di Bursa Efek Indonesia.. Sumber data yang digunakan yaitu data sekunder berupa laporan keuangan perusahaan, serta teknik pengumpulan data menggunakan metode analisis digunakan regresi linier data panel dengan *software* E-Views 10.

Hasil penelitian ini menunjukkan bahwa: 1) Secara parsial variabel *Earning Per Share* berpengaruh positif signifikan Terhadap Harga Saham Perusahaan manufaktur sub sektor makanan dan minuman. 2) Secara parsial *Return On Asset* berpengaruh positif signifikan Terhadap Harga Saham Perusahaan manufaktur sub sektor makanan dan minuman. 3) Secara parsial *Return On Equity* berpengaruh positif signifikan Terhadap Harga Saham Perusahaan manufaktur sub sektor makanan dan minuman. 4) Secara Parsial variabel *Dividen Payout Ratio* berpengaruh signifikan Terhadap Harga Saham Perusahaan manufaktur sub sektor makanan dan minuman. 5) Secara Bersama Simultan variabel *Earning Per Share*, *Return On Asset*, *Return On Equity*, dan *Dividen Payout Ratio* berpengaruh positif signifikan Terhadap Harga Saham Perusahaan manufaktur sub sektor makanan dan minuman.

## **ABSTRACT**

*The thesis entitled "The Influence of Earning Per Share, Return On Assets, Return On Equity, and Dividend Payout Ratio on Share Prices in Manufacturing Companies Listed on the Indonesian Stock Exchange for the 2019-2023 Period" was written by Maya Widya Putri, NIM. 126406202144, supervisor Amalia Nuril Hidayati, S.E., M.Sy.*

*This research is motivated by the growth of share prices which can be influenced by the company's financial performance such as internal factors in the form of financial reports Earning Per Share, Return On Assets, Return On Equity, and Dividend Payout Ratio, with the development of financial reports it can influence fluctuations in manufacturing company share prices. food and beverage sub-sector listed on the Indonesian stock exchange.*

*The objectives of this research are: 1) To find out whether there is a significant influence of the Earning Per Share variable on share prices of manufacturing companies in the food and beverage sub-sector. 2) To determine the significant influence of the Return On Asset variable on share prices of manufacturing companies in the food and beverage sub-sector. 3) To determine the significant influence of the Return On Equity variable on share prices of manufacturing companies in the food and beverage sub-sector. 4) To determine the significant influence of the Dividend Payout Ratio variable on share prices of manufacturing companies in the food and beverage sub-sector. 5) To determine the simultaneous significant influence of the variables Earning Per Share, Return On Assets, Return On Equity, and Dividend Payout Ratio on share prices of manufacturing companies in the food and beverage sub-sector.*

*This research uses a quantitative approach with an associative type of research. The population used in this research is quarterly data from food and beverage sub-sector manufacturing companies listed on the Indonesia Stock Exchange. The data source used is secondary data in the form of company financial reports, as well as data collection techniques using analytical methods using panel data linear regression with software. E-Views 10.*

*The results of this research show that: 1) Partially, the Earning Per Share variable has a significant positive effect on share prices of manufacturing companies in the food and beverage sub-sector. 2) Partially, Return on Assets has a significant positive effect on share prices of manufacturing companies in the food and beverage sub-sector. 3) Partially, Return on Equity has a significant positive effect on share prices of manufacturing companies in the food and beverage sub-sector. 4) Partially, the Dividend Payout Ratio variable has a significant effect on the share prices of manufacturing companies in the food and beverage sub-sector. 5) Simultaneously, the variables Earning Per Share, Return On Assets, Return On Equity, and Dividend Payout Ratio have a significant positive effect on the share prices of manufacturing companies in the food and beverage sub-sector.*
